

#### A Note from the Publisher

#### Dear Readers,

Thank you for reading and participating in this fourth edition of "Notable Women in Kentucky Politics and Government." This special edition of The Kentucky Gazette celebrates the women who work in public affairs to advance the commonwealth.

The women showcased here may not always align politically or ideologically with each other, they may argue opposite sides of an issue, but they do have a singular goal: To make Kentucky better in whatever way they see possible.

Some of these women work toward that goal by serving in elected office, some by advocating for business and economic growth, others by fulfilling the missions of nonprofits that work closely with government agencies that, too, often are headed by women.

Women are leaders in all three branches of Kentucky government, they are CEOs and executive directors, they are lobbyists and lawyers and engineers. They also are band moms and board members, veterans and farmers.

In short, the women on these pages represent some of

the most powerful and intelligent leaders in their communities, their regions and the commonwealth.

Women make up just over half - 50.3% - of the Kentucky population, according to the U.S. Census Bureau, but they generally don't make up half of the leadership in the public entities or in private business in the commonwealth.

The Kentucky General Assembly is dominated by men. In the Kentucky Senate, nine of 38 members, or 24%, of the senators are women. This is an increase over last year, when six senators were women, then comprising 16% of the upper chamber in 2022.

Things are pretty much status quo in the lower chamber from last year. In the Kentucky House of Representatives, 33 of 100 members are women, an increase of one member and 1% over last year.

In the administration of Gov. Andy Beshear, three of 11 cabinet secretaries (Energy and Environment Cabinet, Finance and Administration Cabinet, and the Personnel Cabinet), the lieutenant governor and Beshear's chief of staff are women. Last year, four cabinet secretaries were women.

The judicial branch is the most balanced of the three branches. Three of seven members of the Kentucky Supreme Court are women, including one featured in these pages, and women make up the majority on the Kentucky Court of Appeals, where eight of 14 judges are women.

In the Fourth Estate, most members of the Capital Press Corps are men.

Earlier this year, The Kentucky Gazette asked its members and social media followers to nominate women who make a difference in Kentucky public affairs. Nominators emailed us names and reasons why these women should be honored. Several of these women were nominated by more than one person.

You'll also notice a few people this year who have been honored in past years. We deliberated about including people another time and decided we would, since their work in the intervening time warrants new attention.

The women showcased in these pages are leaders in the field of public affairs.

#### **AMY ALVEY**

**OLDHAM COUNTY** 

Amy Alvey has been involved in local government for 25 years and most recently became the Oldham County clerk in August 2022.

As county clerk, Alvey oversees an office that is the legal depository for all county records, including deeds, wills, mortgages and many other records, as well as the registration of all the vehicles within the county. She also is charged with overseeing the election process from start to finish each election cycle.

Before becoming clerk, she served as assistant planning director in the planning and zoning office, where she worked with developers to ensure Oldham County moved forward with smart, managed growth.

Alvey began her public service career in 1998 as the finance officer and grants administrator for the Oldham County Fiscal Court before

being appointed county treasurer in 2004. She later served as controller, board treasurer and interim director for the Oldham County Sewer District.

She served on the LaGrange Fire Protection District board, starting in 2010, and chaired the board from 2013 to 2022.

As a family advocate for the Brain Injury Alliance of Kentucky, her family meets with the families and loved ones of those who have suffered a traumatic brain injury to give them hope and insight into the road to recovery by sharing her story

A fourth generation Oldham Countian, she lives in LaGrange with her husband of 25 years, Tim. They have three daughters and two grandchildren.

#### **ALLISON BALL**

KENTUCKY TREASURER'S OFFICE

Allison Ball is the 38th state treasurer of the Commonwealth of Kentucky. A University of Kentucky College of Law graduate, Ball practiced bankruptcy law and spent time as an assistant Floyd County attorney before serving as state treasurer.

She currently is serving her second term as Kentucky State treasurer. She is a watchdog for taxpayer dollars and a national leader for financial empowerment. She advocated for the creation of Kentucky's financial literacy highschool graduation requirement, established the Kentucky Financial Empowerment Coalition and Database, and successfully championed the creation of the Kentucky Financial Empowerment Commission.

Since taking office, she has returned a record \$171 million in unclaimed property and returned more in a single term than any state treasurer in Kentucky history. She also launched a new transparency website, making it easier for Kentuckians to see how state government is spending their money.

Her office has thwarted millions of dollars in fraud attempts on the commonwealth. Additionally, Ball started a savings and investment program for Kentuckians with disabilities called STABLE Kentucky.

Ball and her husband, Dr. Asa James Swan, have two children, Levi and Marigold.

#### **KIMBERLY HENDERSON BAIRD**

**FAYETTE COUNTY** 

Kimberly Henderson Baird serves as the Fayette commonwealth's attorney in Lexington. She began her career as an assistant commonwealth's attorney in 1996 and was promoted to first assistant in 2016. She was appointed by Gov. Andy Beshear to fill the remainder of her predecessor's term, beginning Oct. 1, 2022.

Baird is the first African American woman in Kentucky and the first African American in Fayette County to serve in the role of commonwealth's attorney. She is a member of the office's Special Victim's Unit, focusing on crimes committed against children, facilitating the multi-disciplinary team meetings held at the Children's Advocacy Center, which investigates and prosecutes child sexual abuse cases, and she serves on its board of directors.

She serves on numerous local, state and national boards, and also was inducted as a fellow into the prestigious American College of Trial Lawyers.

She was born and raised in Lexington. She graduated from the University of Kentucky in 1993 and the UK College of Law in 1996.

She is the board treasurer for the Community Action Council and has served as chair of Lexington's Annual Roots and Heritage Festival for the past 18 years. She is an honorary member of Sigma Gamma Rho Sorority Inc. and serves as the Usher Board president at Historic Pleasant Green Missionary Baptist Church, where she has been a member for over 40 years.

#### **STEPHANIE BELL WINDSTREAM**

Stephanie Bell is vice president of government affairs at Windstream, a leading provider of advanced network communications and technology solutions. In that role, Bell spearheads policy on state and local levels, and she works closely with communities across the commonwealth.

Prior to her position at Windstream, Bell spent more than 20 years in government, which included serving on the executive staff in the governor's and lieutenant governor's offices as well as serving as deputy executive director of the Kentucky Public Service Commission.

Bell also previously owned and operated a consulting business with a focus on energy, telecommunications and lobbying. She recently was elected to serve on the Ken-

tucky Chamber of Commerce Board of Directors. In addition to her role on the chamber's board, she previously served as the chair of the chamber's Infrastructure and Technology Policy Council.

Bell also serves as chair and trustee for the Kentucky Community and Technical College System Foundation Board. Recently, she was appointed by Gov. Andy Beshear to serve a four-year term on the Tourism Development Authority.

Her past roles include serving as a committee chair of the Kentucky Association of Economic Development and as an executive committee member of the Kentucky Heart Association Annual Gala.

Bell holds a bachelor's degree from the University of Kentucky.

#### **ANGELA BILLINGS**

LEGISLATIVE RESEARCH COMMISSION

Angela Billings is a U.S. Air Force veteran, strategic communicator, entrepreneur and public speaker.

In her role as communication director with the Kentucky Senate majority, Billings and her team handle communication for Republican majority leadership and all Republican state senators.

From press conferences, news releases and public statements to Twitter, Facebook and Instagram, Billings and her team leverage available platforms to promote conservative legislation and Kentucky's business-friendly environment.


Angela McCormick Bisig was elected to the Kentucky Supreme Court in November 2022. She serves the Fourth Supreme Court District, which is Jefferson County.

Bisig has been a member of the Kentucky judiciary for 21 years. She has served in both district and circuit courts and as chief judge of both terms. She is also one of two founding circuit judges in the commonwealth who presided over cases on a newly formed business court.

Bisig worked as a juvenile court judge for many years. She was a founding member of a restorative-justice program that serves to rehabilitate juveniles and bring healing to crime victims. She helped establish a special program called the Enhanced Supervision Docket, providing court supervision of domestic violence

offenders. She also founded Jefferson County's only language- and cultural-immersion training for court system partners.

Bisig is on the board of directors of the Volunteers of America. She served for many years on the board of directors of the World Affairs Council and regularly hosts international delegations in her home. She served on many other boards, including Dare to Care, Sister Cities of Louisville and the University of Louisville. Bisig was voted the Judge of the Year by the Louisville Bar Association in 2013 and 2020. She was named Trial Judge of the Year in 2021 by the American Board of Trial Advocates. Ka'Sondra Brown, a parenting educator and targeted case manager at Mended Counseling and Trauma Services, is deeply committed to addressing disparities affecting families, particularly the disproportionate impact of drugs and alcohol on people of color.

With a bachelor of science degree from Kentucky State University and a certificate in family development from Cornell University, Brown contributes to various Kentucky boards and committees. Notably, Brown served as commissioner of the Kentucky Community Volunteerism and Service, which is housed in the Kentucky Cabinet for Health and Family Services, and is vice chair for Serve Kentucky. Her advocacy and community involvement

extend to her role on the FoodChain Board of Directors since 2019, where she has championed fresh food access and education, focusing on seniors' dietary needs. During the initial COVID-19 pandemic shutdowns, Brown played a pivotal role in developing food distribution services, now known as Nourish Lexington. Nourish has distributed over 801,263 meals since March 2020. One of her proudest achievements is her appointment to the board of directors for Voices of Hope-Lexington, a non-profit organization staffed by individuals in recovery from substance use disorder.

Brown for 10 years has been a foster parent with the Department of Community Based Services and NECCO Foster Care. In 2021, Brown was awarded Transfiguring Adoption's The Best Foster Parent in the United States award.

#### **TRILLE BOTTOM BOYLE COUNTY**

Appointed Boyle County clerk in October 2008, Bottom has run three elections successfully, and she is currently the Boyle County judge executive. As judge executive, her duties include overseeing county departments and working with the department heads in managing employees, preparing the county's \$70 million budget while being fiscally responsible and leading fiscal court meetings.

Bottom began her career with county government in June 1989, working for the Boyle County Sheriff's Department.

She has a passion for helping people in her community through her service with Kiwanis Club of Danville and other organizations. In fact, she has printed her motto on her business cards: "Helping you is what we do." A favorite part of her job is meeting with constituents and

listening to their input. She takes her lead from what she hears from her community. A 1984 graduate of Boyle County High School, Bottom received an associate of science degree in accounting and business administration from Kentucky College of Business in 1986.

She lives with her husband, Mark, on a farm near Perryville where the Bottom family raises beef cattle. Their son Trent and his wife, Lindsey, live in Danville with two children. Son Tatum and his wife, Paige, live in Perryville and have one son.

Bottom is a member of Antioch United Methodist Church, past president of the Kentucky County Clerk's Association, past president and lieutenant governor of Kiwanis. She is a current member of Friends of the Library and serves on numerous boards.

### **ADRIENNE BUSH**

Since 2017, Adrienne Bush has served as executive director of the Homeless and Housing Coalition of Kentucky in Frankfort.

The statewide coalition values housing as a human right and affirms its mission to eliminate the threat of homlessness and fulfill the promise of affordable housing.

At HHCK, she is responsible for day-to-day organizational management, leading state and federal advocacy efforts and overseeing program staff.

Her current role at HHCK comes after 15 years of direct service provision in the homeless, housing and early childhood education fields in Hazard and Perry County and having served on HHCK's board of directors from 2006 to 2015.

Bush staffs the statutorily authorized Kentucky Interagency Council on Homelessness on behalf of HHCK, has served on the Balance-of-State Continuum of Care Advisory Board since 2012, and currently is serving in appointed positions on the Kentucky Affordable Housing Trust Fund Advisory Committee and the Persons Reentering Society Technical Advisory Committee to the Advisory Council on Medical Assistance.

She lives in Frankfort with her family, where she is currently learning how to be a supportive marching band booster mom at Western Hills High School.

#### **JAMIE BEWLEY BYRD**

#### BARREN COUNTY

Jamie Bewley Byrd currently serves as the county judge executive for Barren County. As county judge executive, Byrd is responsible for the administration of the affairs of the county. Those affairs include serving on the Barren County Fiscal Court and executing its ordinances and resolutions, as well as managing all of county government. She first was elected in November of 2022.

She is a fifth-generation Barren County native. She received full-ride scholarships to the dual engineering program of Western Kentucky University and the University of Kentucky. In 2004, she graduated with a bachelor of science degree in civil engineering and minor in math and physics from the University of Kentucky.

Byrd has been a licensed professional engineer since 2009, and she worked for

the Kentucky Transportation Cabinet in the state highway engineer's office. She managed the Kentucky Transportation Cabinet scholarship program, was the engineer career path coordinator, was a Kentucky Transportation Research Center Program coordinator and was a Transportation Research Board Kentucky state representative.

Since leaving the Transportation Cabinet in 2011, Byrd has focused much of her time on bringing business and economic growth to Barren County and the surrounding areas. She is the founder and CEO of The Cheer Leader Magazine and TCLM. She is the owner of Cheerville Athletics and Extreme Gymnastics. She is married to local businessman, Daniel Byrd, and they have four children: Shelby, Sydney, Saylor and Sawyer.

#### ANGIE CAIN KENTUCKY DEPARTMENT FOR LOCAL GOVERNMENT

Angie Cain is a field representative to Gov. Andy Beshear in the Department for Local Government, where she serves as a liaison for local elected officials and constituents in the northern part of Kentucky. She has held this role since Beshear's term began in 2019. Cain's responsibilities include staffing the governor and lieutenant governor at events, attending meetings with community leaders, and talking with judge executives, mayors and constituents about concerns, helping to keep communication with state government open and accessible.

In the past, she was a political consultant, focusing on campaign finance, compliance and fundraising. She also served six years in former U.S. Rep. Ken Lucas's administration as a legislative aide in Washington D.C. and later as district director.

Balancing a 30-year career while raising children, Cain always prioritized serving her community and being an active parent volunteer, as well as mentoring women in politics and government service. She has served on the KET Authority Board and as a Kentucky Ambassador to Cincinnati Children's Hospital. She was a founding member of Legacy, a young professionals leadership program at the NKY Chamber of Commerce.

Cain grew up in Covington, attended Holy Cross, and is a first-generation college graduate of Northern Kentucky University. She and Charlie live on a small beef cattle farm in Walton and have five children: Ryan, Jack and Aly are students at the University of Kentucky; Dillon is a junior at Covington Catholic; Elizabeth is a 4th grader at St. Timothy in Union.

Best known as a public administrative change agent, Colleen Chaney proudly has worked with federal, state and local governments and higher education. Chaney has more than 20 years of experience serving the citizens of the commonwealth.

In 2021, Chaney joined the president's cabinet at Eastern Kentucky University as chief of staff and chief communications officer. She is involved in the daily operation of the university and is focused on elevating Eastern Kentucky University as the game changer for the region and the state.

Prior to joining higher education, Chaney served as public and member relations manager with the Kentucky League of Cities, the youngest female commissioner of the Gover-

nor's Office of Local Development under Gov. Ernie Fletcher, director for the Office of the Secretary of State under Trey Grayson and the first 6th Congressional District director for Congressman Andy Barr.

Serving her home county, she worked as chief deputy clerk in the Madison County Clerk's office and as Madison County deputy judge executive for several years.

Chaney earned two degrees in political science and communications from Indiana University and a master's in public administration from Eastern Kentucky University. She serves as a board member for the Baptist Health Foundation, the Richmond Chamber of Commerce and the Madison County Airport.

#### JULIA BRIGHT CRIGLER

COMMONWEALTH ALLIANCES

Julia Bright Crigler is an experienced political operative who has served in senior roles in numerous legislative and statewide races where she's built a network across the commonwealth.

In 2012, Crigler served as the political director for the Kentucky House Republican Campaign Caucus Committee. In this role, Crigler managed more than 25 key legislative races in Kentucky. It was during this election cycle that House Republicans made significant gains and grew their membership to the highest in Kentucky history prior to moving into the majority after the 2016 elections.



Crigler spent the next three years in the Koch Network as the Kentucky state director for Americans for Prosperity.

She started her own government relations firm, Bright Strategies, in 2017 and formed a strategic partnership with Commonwealth Alliances in Frankfort.

Crigler graduated from Western Kentucky University with a bachelor of arts degree in political science and psychology.

#### **SHARON P. CLARK**

KY DEPARTMENT OF INSURANCE

Sharon P. Clark is commissioner of the Kentucky Department of Insurance, where she works with a talented team of 87 employees to provide regulatory oversight of Kentucky's \$33 billion insurance industry. Gov. Andy Beshear appointed her commissioner on Jan. 6, 2020. She previously served as commissioner from July 2008 to January 2016, making her 11-year tenure the longest since the department was established in May 1870.

Clark started her career as an instructor at her alma mater, the University of Kentucky. After a few years, she began her public service in several agencies, including the House of Representatives and the Public Service Commission. She was the first director of DOI's Consumer Protection and Education Division. Under her leadership, the department hired its first ombudsman and added consumer education and outreach.

She is a member of the National Association of Insurance Commissioners executive committee and serves in many positions, including as vice chair of its Financial Regulation Standards and Accreditation Committee and chair of the Regulatory Framework Task Force.

Nominated by staff of DOI, she is this year's recipient of the Cissy Musselman Women's Leadership Award for her role in leading the department in responding to recent natural disasters, including the March 2023 windstorm, the 2022 floods and the December 2021 tornadoes. She is active in civic organizations and her church. Sharon and her husband have two daughters and four grandchildren.

#### **TATUM DALE** OFFICE OF U.S. REP. ANDY BARR

Tatum Dale serves as district director for Sixth District Congressman Andy Barr. As the congressman's top aide in Kentucky, she oversees the district office team and operations in Lexington, including the congressman's bestin-class constituent services.

Dale regularly meets with constituents, elected officials, agencies and community groups to identify their needs and concerns, and she keeps the congressman apprised.

Dale began her career with the Andy Barr for Congress campaign in 2012. Upon Barr's election, she took an operations role in his Washington D.C. office.

In 2015, Dale returned to Kentucky to work as a field representative in Kentucky's Sixth Congressional District. Dale was promoted to deputy district director in 2017 and to district director in 2019.

Kate Wood Hall has worked in Kentucky politics and government for over 17 years and has been a member of the Commonwealth Alliances team for over nine years.



ians, particularly those who have been excluded or ignored by policy makers. The Breaking Barriers Council is comprised of birth workers seeking reproductive justice in Louisville's West End, doulas in Central Kentucky, medical professionals and others.

McGranahan also was an ACLU of Kentucky Smart Justice advocate, pushing for justice reform and voting rights restoration for Kentuckians with past felony convictions. Her advocacy is informed by her experiences as a Black woman from Appalachia.

She serves on the boards of the Louisville Coalition for Black Maternal Health and the Fairness Campaign, and volunteers with other organizations. She was born and raised in Ashland, and currently resides in Louisville.

PLANNED PARENTHOOD ALLIANCE

Tamarra Wieder has served as the Kentucky state director for Planned Parenthood Alliance Advocates since 2015. As co-chair for the Protect Kentucky Access campaign, she worked to successfully defeat Constitutional Amendment 2 in the 2022 election.

As PPAA-KY state director and one of the organization's registered lobbyists, Wieder manages organizing, advocacy and electoral efforts to promote, protect and advance access to sexual health, education and reproductive rights in the commonwealth.

She also currently serves as the board president for the Commonwealth Alliance Voter Engagement Table, intersecting her passions for reproductive health and justice with a more empowered and engaged electorate.

Prior to Planned Parenthood, Wieder worked with the American Civil Liberties Union and the Human Rights Campaign.

Colleen Younger was elected Jefferson County property valuation administrator in 2018. Her two main goals are to demystify the PVA office and to offer best-in-class customer service.
