

#### A Note from the Publisher

Dear Gazette Readers,

Once again, we are honored to present 50 Kentucky women whose work in the public sphere represents meritocracy and excellence. At a time when some public figures question the ability of women to perform to rigorous standards in the academic, military, and professional worlds, you will read here about women who prove that assertion patently false.

Our Notable Women this year include Ph.D.-holding scholars, attorneys, advocates for businesses and causes, a journalist, public servants, and women who proudly served our nation in uniform.

With literally hundreds of years of combined experience, all 50 Notable Women have exceeded the standards set in their fields: They have received awards, commendations, and accolades from their communities, their institutions, their peers.

Many of this year's Notable Women work in and around Frankfort, where women hold positions of power, but that's generally not the case in other parts of the state. For example, only eight of Kentucky's 120 county judge executives (7%) are women, and two of them are figureheads in Fayette and Jefferson counties. Women serve as mayor in only three (15%) of the commonwealth's 20 largest cities – Lexington, Florence, and Erlanger.

At the state level, the Center for American Women and Politics at Rutgers University says women's representation in state legislatures reached a record high after the 2024 election, with women holding 33.4% of state legislative seats across the U.S. The Kentucky House is on par with that figure – women serve in 33 of the 100 seats, or 33%. On the other side of the Capitol building, though, women make up 21% of the state Senate, holding eight of 38 seats (with one vacancy).

Two of Kentucky's seven constitutional officers (28%) are women – Lt. Gov. Jacqueline Coleman and state Auditor Allison Ball. And

women make up 30% of the state's 10 executive branch cabinets: Secretary Rebecca Goodman, Energy and Environment Cabinet; Holly Johnson, Finance and Administration Cabinet; and Mary Elizabeth Bailey, Personnel Cabinet.

Women are the majority on the seven-member Kentucky Supreme Court, with Chief Justice Debra Hembree Lambert at the helm of the judicial branch. Kentucky is one of 20 states in which women are the majority on supreme court benches, according to the Brennen Center for Justice at New York University School of Law.

The Fourth Estate is working on parity, too. More women are covering Frankfort than in recent years, including reporters and editors from the Kentucky Lantern, the Courier Journal, the Lexington Herald Leader, WLEX, WUKY, Louisville Public Media, and, of course, The Kentucky Gazette.

#### **AMY SULLIVAN ANDERSON**

11th Judicial District

Originally from Greensburg, District Judge Amy Sullivan Anderson graduated from the University of Kentucky with a B.S. in family studies in 1990 and an MBA in 1992.

After a career in real estate appraisal, she returned to UK, receiving her juris doctor degree in 2000. She practiced at Bertram and Cox in Campbellsville while serving as assistant Taylor County attorney and assistant commonwealth's attorney. Anderson also served as the Green County master commissioner.

She was elected district judge for Green, Taylor, Marion, and Washington counties in 2006, and she presides as a special judge for the 11th Circuit Drug Court.

Anderson has served the court of justice on the Chief Justice's Drug Testing Task Force, the Judicial Workload Assessment Committee,

and the District Judges Executive Committee for the Cumberland Region. She currently serves on the Court Facilities Standards Committee, the KBA Wellness Commission, the Continuing Judicial Education Commission and the Electronic Court Record Subcommittee.

Anderson served as secretary of the District Judges Association and co-chair of the District Judges Education Committee for 10 years. In 2023, she was elected to the Judicial Conduct Commission and was awarded the Judge Robert Heaton Award by her peers. Anderson is a founding board member of District Judges for a Better Commonwealth.

She gives her spare time to her church and the American Red Cross. She is married to Kirk and has one son, Ethan.




#### **MEGAN SPARROW ARNOLD**

#### **LINDSEY BURKE**

Ky House of Representatives

Lindsey Burke, a Lexington native, serves as the Democratic state representative for Kentucky's 75th House District. She previously was minority whip in the House caucus and recently was elected minority caucus chair.

Since taking office on Jan. 1, 2023, Burke has been vocal on issues such as access to justice, affordable housing, and reproductive and maternal-health rights.

She holds a B.S in social work from Florida State University, a Master of Arts in social service administration from the University of Chicago, and a juris doctor from the University of Cincinnati College of Law.

Beginning her career as a social worker, she pivoted into law. In law school, she earned the Public Service Award for the Class of 2012. She was chosen by the graduates of the

University of Cincinnati College of Law to receive their 2025 Alumni Achievement Award. In 2017, Burke founded the nonprofit law firm Micah Legal in Lexington. Micah Legal provides sliding-scale civil legal services for individuals and families of moderate to low incomes. The Kentucky Bar Association Young Lawyers Division honored Burke for service to the community, and she was the Fayette County Bar Association's 2023 Outstanding Young Lawyer. She serves on the American Bar Association Committee for Legal Assistance to Military Personnel. She is a Kentucky Colonel and an elder at her church. In her free time, she enjoys taking long walks with her husband, Dylan, and the new baby girl they welcomed earlier this year.




#### **EMILY CHILDERS**


#### **REBECCA HARTSOUGH**


#### **ROBBIN HIGGINS**




Councilmember Shayla Lynch was elected to office in November 2022 and again in 2024.


#### **LUCY A. VANMETER**

A few years ago, she received calls from local AFT members and from AFT national,

telling her AFT 1360 at the community college was in trouble and asking her to help revive it. This is now her goal as the executive director of AFT 1360. Membership and political activism are increasing.

Last year, AFT 1360 formed a coalition with the leaders of the American Association of University Professors from six public universities in Kentucky to fight a bill in the Kentucky General Assembly that would have ended tenure protection for university faculty.

The coalition viewed the end of tenure as the loss of millions of dollars of research grants and a threat to First Amendment Rights. After much discussion with many legislators and public figures, the coalition prevailed.




#### **EMILY WHITE**

- Nominators are confidential.
- Nominations are vetted by staff and contractors of The Kentucky Gazette to ensure they meet these criteria: Notable Women must be top-level professionals in a public affairs position; they must work in Kentucky, for a Kentucky firm, or for a member of Kentucky's delegation in Washington D.C.; and they must be currently serving in the role for which they are nominated.

- After selecting the Notable Women, The Kentucky Gazette sends each nominee a letter via the U.S. Postal Service, letting them know they have been selected. The letters ask nominees to submit a 250-word biography and a high-resolution head shot.
- The Kentucky Gazette staff edits biographies for clarity, style, and length only. We do not fact check the nominees' biographical claims.
- The Kentucky Gazette staff crops photos for size consistency, and edits for color correction and clarity as necessary for quality, four-color printing.
